Hazard Identified? / Risks from it?	Who is at risk?	How are the risks already controlled? What extra controls are needed?	What has changed that needs to be thought about and controlled?
Hazard – something that may cause harm or damage. Risk – the chance of it happening.	Young people, Leaders, Visitors.	Controls – Ways of making the activity safer by removing or reducing the risk from it.  For example - you might use a different piece of equipment or you might change the way the activity is carried out.	Keep <b>checking</b> throughout the activity in case you need to change itor even <b>stop</b> it! This is a great place to add comments which will be used as part of the review.
Use of incorrect equipment Falls, falling objects	Volunteers Leaders Staff	<ul> <li>User to ensure access equipment is of adequate height.</li> <li>Consideration given to hiring suitable equipment for specific jobs.</li> </ul>	
Defective equipment Falls, falling objects	Volunteers Leaders Staff	<ul> <li>All access equipment suitable for purpose, checked before use and maintained in good condition.</li> <li>Frequent documented checks on ladder to ensure safe working condition (6 monthly / termly)</li> <li>Reporting procedure in place for identified defective items with prompt removal /remedial action.</li> </ul>	
Inappropriate use of access equipment Overreaching, stretching etc. Uneven floor causing instability Falls, falling objects	Volunteers Leaders Staff	<ul> <li>User trained in use of ladders.</li> <li>Access equipment restricted to those trained and competent in use.</li> <li>Maximum working height not exceeded.</li> <li>Ensure correct angle of ladder (1m out for 4m up)</li> <li>Secure ladder using identified fixing points.</li> <li>No lone working when using ladders.</li> <li>Re-position ladder rather than overstretch.</li> <li>Ground surfaces suitable to use (firm and even surface)</li> <li>Persons using access equipment to wear appropriate footwear (low heeled, non-slip soles)</li> <li>Securely stored when not in use to avoid unauthorised use.</li> </ul>	



Persons colliding with ladder	Volunteers Leaders Staff	<ul> <li>Segregate work area effectively.</li> <li>Provide warning signs, cones or fencing if needed.</li> </ul>
Manual Handling Unstable / unwieldy loads Falls, falling objects  Environmental conditions (weather, wet ground, uneven surfaces etc.) Falls, falling objects	Volunteers Leaders Staff  Volunteers Leaders Staff	<ul> <li>Schedule work to take place when persons are not in immediate area.</li> <li>Accompanying tools and equipment carried leaving both hands to be kept free when climbing ladder.</li> <li>Use team handling where necessary.</li> <li>Training in moving and handling techniques.</li> <li>Obtain help transporting ladder and equipment, if needed</li> <li>Consideration given to environmental conditions prior to starting work.</li> <li>No work to be undertaken in adverse weather conditions (wind, rain, snow etc.)</li> <li>Ensure ladder is clear of slippery substances, ice, mud etc.</li> </ul>
Access to roof by unauthorised persons Falls, falling objects	Volunteers Leaders Staff	<ul> <li>Facilities Director is the only authorised person to permit access to roofs</li> <li>No lone working when using ladders.</li> </ul>
Fragile roof/skylights Falls, falling objects	Volunteers Leaders Staff	<ul> <li>Fragile roof / skylights are either covered, signed as hazardous or have physical barriers around them. In some instances access to the location is restricted to those using fall restraint / arrest equipment.</li> <li>Where skylights exist avoid these hazard areas where possible.</li> </ul>
No edge protection Falls, falling objects	Volunteers Leaders Staff	<ul> <li>A safe system of work which sets out the precautions to be taken by users.</li> <li>No person to be within 2 metres of an unprotected roof edge unless they are using fall arrest / restraint apparatus.</li> <li>Users to give full regard to weather conditions when planning works on unprotected roofs.</li> </ul>
Sloping Roof Falls, falling objects	Volunteers Leaders Staff	Sloping roofs are not to be walked on unless they are using fall arrest / restraint apparatus.
Slippery roofs Falls, falling objects	Volunteers Leaders Staff	Wear appropriate footwear when accessing roofs and exercise caution where roofs are wet or icy.



Overloading roof Falls, falling objects	Volunteers Leaders Staff	<ul> <li>Where heavy plant or materials are to be placed on a roof     consideration must be given to the safe working load of the roof.     Where there is any doubt the Facilities Director must be consulted.</li> </ul>
Poor or no lighting Falls, falling objects	Volunteers Leaders Staff	<ul> <li>Do not carry out work operations in poorly lit areas.</li> <li>Provide additional lighting – extension leads, torches if required etc.</li> <li>Beware of trip hazards presented by extension leads.</li> </ul>
Falling objects Injury	Volunteers Leaders Staff	<ul> <li>Where tools or equipment are being used adjacent to a roof edge and there is a risk of them falling and injuring those below those items must be attached to a safety lanyard.</li> <li>Be particularly mindful of the 'sail' effect which large work materials can produce e.g. plywood, glazing. This sail effect can be extremely hazardous even in light winds blowing material off towers</li> </ul>
Head height obstructions (trees) Falls, injury	Volunteers Leaders Staff	<ul> <li>Be aware of overhanging tree branches, place physical barriers around them.</li> <li>Limit access to the location is restricted to those using fall restraint / arrest equipment.</li> </ul>
